

Terms and Conditions - Refer A Friend

M4Markets, hereinafter referred to as the Company invites traders to participate in its "Refer A Friend" Promotion ("hereinafter referred to as "the Promotion") subject to the terms and conditions contained herein.

The Promotion is available to direct clients trading on M4Markets MT4/MT5 accounts provided that they are eligible to participate In the Promotion subject to the Company's eligibility criteria as indicated in the Client Services Agreement and these terms.

To participate in the Promotion, the participants should have already completed the steps required for opening an account with the Company and they should have also completed client due diligence and KYC and have their account activated.

How to refer a friend:

- Register for a Live account, or if you already have one login into your account
- · Navigate to the 'Refer a Friend' section in your Client Area
- Your referral link will be created automatically or you can create your own link
- Share the link via email or social media
- You can see your referred friends in the dedicated section in your Client Area

The Promotion's conditions:

- 1. Only applicable to verified clients of M4Markets trading on MT4/MT5 Accounts.
- 2. Available to all Direct Clients. Clients who are referred by IBs or IBs are not eligible for this promotion.
- 3. The Promotion offers each client the opportunity to earn \$5 for each lot a referred friend completes trading FX & Metals on a Standard Account, \$2.60 for each lot a referred friend completes trading FX & Metals on a Raw Spread Account and \$2 for each lot a referred friend completes trading FX & Metals on a Premium Account. There are no limitations to the amount of referrals a client can make or any limitations to the amount s/he can earn.

- 4. Any abuse to have multiple profiles to have this promotion is considered as a Trading Abusive Behaviour.
- 5. By participating to the Promotion, the Client acknowledges that s/he has read and agreed to be bound by these Terms and Conditions as well as to the Client Services Agreement.
- 6. To participate in the promotion newly referred clients will need to complete M4Markets' registration form, complete their Economic profile and upload the required documents in the Client Portal to verify their profile. Once their profile has been approved, Clients can navigate to their Client start referring.
- 7. The Company will not be liable for any stop outs or any other consequences that result out of a Bonus cancellation and/or removal.
- 8. Clients cannot refer themselves.
- 9. The reward will be paid to the Client's Wallet and it may be transferred to the Client's trading account. The reward is bit redeemable in cash and it cannot be transferred to any other account holder.
- 10. If the Company suspects that a participant has abused the rules of the Promotion and/or has been identified to have engaged in abusive trading behaviour in any way, then the Company reserves the right at any time and at its sole discretion to immediately exclude the participant from the Promotion and take additional actions depending on the abuse.
- 11. The Promotion is not available to clients USA, Canada, Cuba, Sudan, Syria and North Korea.
- 12. Each client can refer the same friend only once regardless of the number of trading accounts opened by their friend.
- 13. The Company will be entitled to (list not exhaustive):
- a. deny, withhold, or withdraw from that participant the credit bonus and any profits generated from the abusive trading behaviour*.
- 14. The Company reserves the right to modify or cancel the Promotion at any time and at its sole discretion or cease this Promotion without any prior notice.
- 15. M4Markets is a trade name of Trinota Markets (Global) Limited a company regulated as a Securities Dealer by the Financial Services Authority of Seychelles with license number SD035.
- 16. The Promotion is open only to individuals who are at least 18 years of age and have a solid understanding of FX and CFD trading.
- "17. In the event of any dispute misrepresentation of the above applicable Terms, such dispute or misinterpretation shall be resolved in good faith to achieve a fair and equitable resolution. The decision shall be final and binding."
- 18. Nothing in this Program creates any partnership, joint venture, agency, franchise, sales representative, or employment relationship between the Referrer, Referral and M4Markets.
- 19. The translated language of this document, the English wording shall be the binding version in the event of any discrepancy between any two languages.

- * Abusive behaviour is considered (list not exhaustive):
- · multiple registrations from the same IP address
- \cdot trading activities that can be counted as fraud, manipulation or attempts to garner risk free profits
- failure by the client to meet certain requests by the Company related to the Promotion within the specified deadline provided in the correspondence with the Company
- \cdot the participation to the Promotion of third parties on behalf of the IB without the proper authorization or right to act
- trades entered or exited with latencies
- · hedging an open position in less than 2 minutes
